Description:

The Texas Engineering Extension Service (TEEX) will be offering this course virtually. The Disaster Preparedness for Hospitals and Healthcare Organizations within the Community Infrastructure course provides information specific to hospitals and organizations vulnerability to a disaster. Participants will be introduced to the various natural, technological, and civil hazards to which hospitals and healthcare organizations may be vulnerable and the potential impacts of those hazards.

Federal guidelines and legislation that serve to aid in the preparedness for, and response to, incidents involving these hazards are discussed, as are current emergency management standards for the hospital community. Participants review response and recovery issues that should be addressed by medical facilities and organizations in preparation for a large-scale incident, including identification of critical resources necessary for response and recovery.

Objectives: At the conclusion of the course, participants will be able to:

- Discuss threats to hospital infrastructure preparedness.
- Discuss the fundamentals of preparedness.
- Discuss the development of hospital emergency plans.
- Discuss preparation for the recovery phase of a large scale disaster event.
- Assess the preparedness levels of their healthcare facilities/organizations using medical surge as a model.
