## UPDATE: i-STAT CG4+ (blue) and G3+ (blue) Blood Gas Cartridges May be Used in Moderate Complexity Laboratories During the COVID-19 Public Health Emergency

Dear Valued Abbott Point of Care Customer,

We are writing to advise that in light of the COVID-19 public health emergency, the U.S. Food and Drug Administration (FDA) and Centers for Medicare and Medicaid Services (CMS) are allowing the use of the i-STAT CG4+(blue) and i-STAT G3+ (blue) blood gas cartridges in laboratories and facilities that hold a Certificate of Compliance or Accreditation to run tests of moderate complexity.

Specifically, during the COVID-19 pandemic Abbott Point of Care may continue to distribute the i-STAT CG4+ (blue) and i-STAT G3+ (blue) cartridges, and facilities that possess a non-waived CLIA certificate (i.e., facilities that hold a Certificate of Compliance or Accreditation) may use them with venous and arterial whole blood samples as tests of moderate complexity. This is a change from the last customer communication Abbott Point of Care provided to customers on January 15<sup>th</sup>, 2020.

This applies to all i-STAT CG4+(blue) and i-STAT G3+ (blue) cartridges, including those that you may already have on hand. Until the end of the COVID-19 public health emergency, please order the i-STAT CG4+ (blue) and i-STAT G3+ (blue) cartridges using the list numbers in the above table. Abbott Point of Care will provide additional information regarding the disposition of these tests at the termination of the COVID-19 pandemic.
