TITLE: *Artificial Intelligence and the Future of Mental Health Care*

SPEAKER: Serife Tekin, PhD, Associate Professor, Center for Bioethics and Humanities, SUNY Upstate Medical University

DESCRIPTION: Artificial intelligence (AI) is rapidly transforming mental health care through the rise of psychotherapy chatbots that promise affordable, scalable, and stigma-free support. Their adoption- accelerated by governmental regulatory approvals and optimism about precision psychiatry- suggests a future in which mental health interventions are increasingly automated. This talk critically examines that future.

1. Describe the emerging role of artificial intelligence in mental healthcare and its potential to address (or exacerbate) disparities in access and quality of care.
2. Critically assess the assumptions underlying AI-powered care and their implications for global and cross-cultural applicability.

TITLE: *Loneliness: Implications for Mental Health and Treatment Applications*

SPEAKER: Roger McIntyre, MD, Professor of Psychiatry and Pharmacology, University of Toronto

DESCRIPTION: During the last decade, increasing attention has been paid to the pandemic of loneliness and its implications for human health, civic engagement, and measures of trust. Emerging during this time is a confluence of literature also indicating that loneliness, triggers neural biological systems, relevant to mental health and resiliency practitioners providing care to persons, living with mental health disorders encountered disorders that exist with larger macro environment, which includes loneliness, social isolation, and other aspects of precariousness. This presentation will focus on the impact of loneliness across many aspects of health outcome, both mental and physical review, the neural biological consequence of illness and discuss implications for the presentation of mental illness, choosing treatments, and integrating healthcare.

LEARNING OBJECTIVES: Following this activity, the participants should be able to:

1. Define and operationalize the term 'loneliness'.
2. Discuss the health implications of loneliness at a population level.
3. Review the neurobiology of loneliness and its implications for mental health and its treatment.
