NEW YORK CITY POISON CONTROL CENTER

Consultants' Conference is a monthly meeting attended by medical toxicologists, emergency physicians, pharmacists and other learners from all over the Northeast. It is an educational activity in which the *Consultants* (renowned experts in various medical specialties) provide insight into the analysis and approach to the diagnosis and treatment of interesting toxicologic cases. The cases are presented mostly by the NYU Toxicology fellows in training but anyone can present their case if deemed appropriate. Learners of all levels are able to benefit from the rich and often dynamic discourse.

The next Consultants' Conference will be held next week on Thursday, March 7, 2019 starting at 2:00 PM and ending at 4:00 PM in the Public Health Laboratories auditorium. The location of PHL is 455 First Avenue, at 27th Street and 1st Avenue in Manhattan.

- 1. A 44-year-old woman with a past medical history of atrial fibrillation and major depression presents to the ED with decreased responsiveness after reportedly having "palpitations" for the past few days. EMS vital signs are: BP, 60/palp mmHg; P, 20 - 30. In the ED, a transcutaneous pacemaker is applied immediately and capture is obtained.
- 2. A 73-year-old woman is intubated for coma and respiratory depression not responsive to intranasal naloxone. Her vital signs are: BP: 128/89 mm Hg; HR, 56 beats/minute; RR, 14 breaths/minute ventilated; Sat, 100% (FiO₂ 1.0, PEEP 5); T, 94.9° F; FS glucose, 83 mg/dL
- 3. A 3-year-old boy with no significant past medical history presents to the ED with drooling after an ingestion of an unknown liquid. On arrival, his vital signs are: BP, 122/73 mmHg; HR, 114 beats/minute; RR, 24 breaths/minute; O₂ Sat, 99%; T, 98.0°F; POC glucose, 164 mg/dL.
