NEW YORK CITY POISON CONTROL CENTER



Consultants' Conference is a monthly meeting attended by medical toxicologists, emergency physicians, pharmacists and other learners from all over the Northeast. It is an educational activity in which the *Consultants* (renowned experts in various medical specialties) provide insight into the analysis and approach to the diagnosis and treatment of interesting toxicologic cases. The cases are presented mostly by the NYU Toxicology fellows in training but anyone can present their case if deemed appropriate. Learners of all levels are able to benefit from the rich and often dynamic discourse.

The next Consultants' Conference will be held next week on Thursday, May 2, 2019 starting at 2:00 PM and ending at 4:00 PM in the Public Health Laboratories auditorium. The location of PHL is 455 First Avenue, at 27th Street and 1st Avenue in Manhattan.

- 1. A 66-year-old woman presents to the ED with tachypnea after an intentional suicidal ingestion of a liquid one hour prior to presentation. Her initial vital signs are: BP, 110/60 mm Hg; HR, 85 beats/min; RR, 26 breaths/min; T, 97.8°F; O₂ Sat 97% (RA).
- 2. A 38-year-old woman with a past medical history of Crohn's disease is admitted to the hospital for small bowel obstruction after she reports receiving a parenteral herbal treatment one week prior to admission. Her presenting vital signs are: BP, 122/70 mm Hg; HR, 79 beats/min; RR, 20 breaths/min; T, 97.6°F; O₂ Sat 95% (RA).
- 3. A 15-month-old girl with no known significant past medical history, in the US visiting with her family, presents to the ED with unresponsiveness after a suspected overdose. She immediately has a generalized tonic-clonic seizure and then has an aystolic cardiac arrest. The only vital sign obtained prior to her cardiac arrest is a pulse oximetry reading: 75% (RA).
