ID Bands Must Be ON Your Patient!

- We have recently seen a increase in events related to patients not have an ID band on
- This includes concerns with tests, procedures, even the wrong patient being admitted to a unit



- Please make sure your patient has an ID on and remember to check your patients ID prior to assuming care to confirm you have the correct patient

Blue Chuck for Foleys

- All Foley's need a blue chucks pad under the foley bag
- Why? To avoid the bag from touching a dirty floor. The bed should be in the lowest position to prevent falls which puts that bag VERY close to a dirty floor. The blue chucks provides a clean surface should the bag come in contact with the floor.



Urine Samples

- The method of urine collection is important to reduce contamination!
- UA - can collect by bag, cotton balls, clean catch, or catheterization
- Urine culture - can only collect by clean catch or catheterization



Tenecteplase (TNK) for Pediatric Strokes

- We have officially transitioned over to Tenecteplase (TNK) for pediatric strokes when a thrombolytic is indicated

Pre-RRT Huddle

- Goal: promote consistent communication and structure an RRT Huddle will occur outside the patient's room prior to team entry. This huddle ensures all responding team members have arrived before the RRT begins and allow for crowd control prior to

Social Work Consults


If a biological parent is not present with a pediatric patient upon presentation to Upstate, Social Work must be contacted to confirm who can consent and to determine an appropriate decision maker for the patient.

- Example - kiddo presents with grandparent, aunt/uncle, family friend, etc...call social work!



Safety Huddles for ≥ 20 yr old Admissions to UGCH

- All patients admitted to UGCH need to be under a pediatric service (surgical services who operate on both peds and adults is allowed)
- Policy reference [CM P-77 Pediatric Emergency Medical Responses](#)
- All patients ≥ 20 years old (exception: peds hem/onc) will have a proactive safety huddle to ensure clear communication of practice considerations and a resuscitation plan. Contact the Pediatric Quality & Safety Team to facilitate!

Breast Milk Syringe Pumps

- Breast Milk Syringe Pumps are now available for

PRN Order Indications

- Please be sure you are following the parameters in PRN orders

NGT Placement Reconfirmation

- Recheck placement prior to using the NGT for

- patients requiring NG feeds with breast milk!
- Obtain pump from Equipment
- Use orange Medela ENFit syringe and tubing stocked on the unit

- For example - Tylenol ordered prn for temp > 38.5 ...you cannot give Tylenol when the temp is below this (ie. 38.2, 38.4). If the patient needs Tylenol in this example, a one time order is required.

- feeding or medication administration
- Primary method of reconfirmation is measurement. May use gastric pH but this is not required or often necessary.

New Toddler Beds!

- We have new toddler beds!
- They are amazing BUT have an important **weight limitation of 150lbs**
- Parents cannot be laying in toddler beds
- When we had them in the past, they all broke from consistently holding weight > 150 lbs. If we want to keep them please help to enforce this weight limit!

Annual recertification is CLOSING 1/31/2026!!

- If you were originally certified through the PNCB **before 1/1/2025**, you'll need to recertify this cycle 11/1/25-1/31/26 (you can ONLY recertify during this period.)
- Submit an application for recertification in self serve - click on 3 lines in upper left corner, under Nursing, click on Nursing Certification --> click on New Form --> Application For: Recertification --> Request For: Advance Payment --> type "code" for username and password
- The No Pass, No Pay code will be sent to you once your application is approved.
- **The No Pass, No Pay code cannot be used after 1/31/26 ***
- Recertify through pcnb.org at no charge when using code


